REIMBURSEMENT GUIDELINES FOR PHYSICIANS OR DENTISTS MOVING TO THE SOUTHERN UNION

[Only baptized members of the Seventh-day Adventist Church are eligible for this program.]

The local regional and state Seventh-day Adventist conferences together with the Southern Union Conference of Seventh-day Adventists [SUC] provide the funds for this program*. These funds are given to help you relocate to the place of your new employment and/or training. Please make a copy of original receipts and retain the originals for your personal records. Each applicant may receive up to a maximum of \$5000 in reimbursable expenses (with accompanying receipts).

- 1. All applications will be processed through the SUC office. Applications are to be submitted within a reasonable amount of time once the move is completed. Medical/Dental professionals may apply only once to the SUC for moving/travel expense reimbursement.
- 2. If the hiring organization you will be joining or working for pays for any part of your move, you are disqualified from this program.
- 3. If a husband and wife are both doctors (physician and/or dentist), both may individually apply for reimbursement but receipts may be turned in only one time.
- 4. For already practicing dentists/physicians who are moving to the SUC please send in a copy of your license to practice with your application.
- 5. Reimbursement will be made on presentation of copied original receipts that represent the actual expenses incurred from <u>direct travel to and from appointed destinations</u>. Only direct flights or flights involving transfers are acceptable. NO stopovers are permitted. If driving, only a direct route from point A (Current Address) to point B (New Address) is allowed. PLEASE DO NOT COMBINE WITH OTHER TRAVEL, IE., SIDE TRIPS, VACATION, ETC.
- 6. We reimburse hotel expenses for a maximum of four nights when moving from the West Coast to the SUC for practicing physicians and dentists or those seeking residency or fellowship programs.
- 7. Reimbursable expenses include:
 - Lodging for the move and/or for interviews and house-hunting trips.
 - Moving/shipping services for household goods
 - Packing materials for the move, i.e., boxes, tape, Styrofoam, bubble wrap, etc.
 - Gasoline for your personal vehicle or rental truck if you are moving yourself
 - Shipping a personal vehicle [auto/motorcycle] if a moving service is moving you.
 - Travel expenses for interviews within the SUC
 - Travel expenses for house hunting trips within the SUC

Non-reimbursable expenses include:

- Food or per diem
- Mileage

Completely fill out the two-page application, making sure you sign the W-9 form on the second page and attach it, along with a photo, and a copy of your receipts and send to: bdavidson@southernunion.com.

THE SOUTHERN UNION CONFERENCE OF SEVENTH-DAY ADVENTISTS

The Southern Union Conference [SUC] is comprised of the following eight states: Alabama, North and South Carolina, Florida, Georgia, Kentucky, Mississippi and Tennessee.

These states comprise the following conferences which make up the SUC:

Carolina Conference – North Carolina, with the exception of Cherokee County, and South Carolina.

<u>Florida Conference</u> – Florida, with the exception of Bay, Calhoun Escambia, Gulf, Holmes, Jackson, Okaloosa, Santa Rosa, Walton, and Washington Counties.

<u>Georgia-Cumberland Conference</u> – Georgia, Cherokee County in North Carolina, and Eastern Tennessee to the eastern boundaries of Cannon, Clay, Coffee, DeKalb, Franklin, Jackson, and Smith Counties.

<u>Gulf States Conference</u> – Alabama, Mississippi, and the following counties in Florida: Bay, Calhoun, Escambia, Gulf, Holmes, Jackson, Okaloosa, Santa Rosa, Walton, and Washington.

<u>Kentucky-Tennessee Conference</u> – Kentucky and Western Tennessee to the eastern boundaries of Cannon, Clay, Coffee, DeKalb, Franklin, Jackson, and Smith Counties.

<u>Southeastern Conference</u> – Regional constituency of Florida except that portion west of the Apalachicola River, and that portion of Georgia south of and including the following counties: Appling, Baker, Ben Hill, Jeff Davis, McIntosh, Miller, Mitchell, Seminole, Telfair, Turner, Wayne and Worth.

<u>South Atlantic Conference</u> – Regional constituency of North Carolina, South Carolina, and Georgia, except that portion of Georgia south of and including the following counties: Appling, Baker, Ben Hill, Jeff Davis, McIntosh, Miller, Mitchell, Seminole, Telfair, Turner, Wayne, and Worth.

<u>South Central Conference</u> – Regional constituency of Alabama and the portion of Florida lying west of the Apalachicola River, Kentucky, Mississippi and Tennessee.
